# **CURRICULUM**

# FOR INTERNATIONAL DOCTORIAL STUDY

**COURSE: INTERNATIONAL BUSINESS ADMINISTRATION** 

#### I. BASIC PRINCIPLES OF STUDY

- 1. Doctoral study course "International Business"
- 2. Teaching, communication, reading and testing is done in English
- 3. Applies methods: Full time, Part time and Online studies
- 4. The three (3) years or six semesters
- 5. Teaching in the I, III and V semester runs from 01.X. to 28 II (next year)
- 6. Classes II, IV and VI semester runs from 01.III to 31 VII.
- 7. Classes are conducted according to schedule I to VI semester (see detail in the Rules of studying art 20)
- 8. Students independently collect points and thus have defined the height of assessment (see detail in the Rules of studying Member from 28 to 37)
- 9. Students collected:
  - Claims 6 cases mandatory,
  - Wrote three essays three of elective subjects,
  - Participate in the international conference,
  - Published a scientific article,
  - Selects, application threads, write and defend a doctoral dissertation (see detailed rules for studying Article 20)
- 10. Doctoral studies in addition to master's economy may enter a non-economic faculties and Masters (details regarding admission to this course of study, see Rules Section 63 72)
- 11. The doctoral program requires from students to greater scope for individual work and individual learning and studying.
- 12. To win one of ECTS credits required is the average workload of 30 hours,
- 13. Compulsory courses taken at 10 ECTS credits or a total load of one case per 300 school hours. Seminar papers carry the 5 ECTS credits. It carries so much participation in international conferences as well as writing and publishing scientific article.

- Working on his doctoral dissertation 70 ECTS
- The defence of a doctoral dissertation 10 ECTS

17. The activities carried out by doctors of science in the field of international business relations at the highest volume and complexity of knowledge regarding international business. These are jobs in scientific institutes, state agencies, chambers of commerce, international institutions and managerial positions in companies, banks, marketing organizations and other institutions involved in international business. The holder of a doctoral degree can work in a variety of expert teams and be hired as a professor at colleges and high schools.

#### 18. Knowledge, qualifications and skills acquired through completion of the study:

Diplomas or classifications are obtained after the third cycle of studies, doctoral studies three years while getting new (additional) 180 ECTS credits awarded to students, a Ph.D. student who:

- Show understanding of a systematic field of study and mastery of skills and methods of research in connection with the given area;
- demonstrate the ability to define the research study design, and conduct research in accordance with the methodology given science;
- Original research provides its own scientific contribution that expands the boundaries of knowledge in a given area;
- Are capable of critical analysis, evaluation and synthesis of new and complex ideas;
- May in connection with their area of professional and scientific knowledge to communicate with colleagues throughout the scientific community and society;
- Will continue scientific research and development and be initiators and bearers of progress in knowledge-based society, contributing to the continuous development of new techniques, ideas or approaches.

In addition, students will gain the specific knowledge and skills in the field of study, which include:

- Generic knowledge in management skills for effective organization and management, in a multi-cultural and cross-cultural environment
- Selection of appropriate styles and modes of communication for complex tasks and purposes
- Knowledge and understanding of a wide range of specific and general theories, strategies and research methods and research to solve professional problems
